## **Essential Elements of the Well Woman Exam**

## History

- 1. Reason for visit/chief complaint
- 2. Health status: medical/surgical, menstrual, reproductive health
- 3. Family medical history
- 4. Dietary/nutritional assessment
- 5. Physical Activity
- 6. Medications: prescription, OTC, complementary/alternative
- 7. Tobacco, alcohol, drug use
- 8. Emotional, physical, sexual abuse, neglect
- 9. Sexual practices: type, orientation, number of partners, contraceptive use, trafficking
- 10.Urinary or fecal incontinence (recommended all patients over 20)
- 11. Menopausal symptoms (recommended all patients over 40)
- 12. Pelvic prolapse (recommended all patients over 40)

## Exam

- 1. VS: height, weight, BP
- 2. BMI
- 3. General health assessment
- 4. Neck: adenopathy, thyroid (recommended all patients over age 20)
- 5. Abdominal exam
- 6. Inguinal lymph node exam
- 7. Clinical breast exam, axillae (recommended all patients ages 20-39 Q1-3yrs; annually after 40)\*
- 8. Pelvic Exam (recommended all patients over 21)\*
  - a. External genitalia
  - b. Urethral meatus
  - c. Vaginal introitus
  - d. Perianal region
  - e. Speculum exam of the vagina and cervix
  - f. Bimanual exam of the uterus, cervix, and adnexa
  - g. Rectovaginal exam if indicated
- 9. Additional exam as clinically appropriate

<u>Additional Elements</u>: Screening, counseling, anticipatory guidance, risk factor reduction interventions, immunizations, and the ordering of laboratory and diagnostic procedures based on age and risk factors

A plan of care for follow-up and any testing must also be documented.
